### **2. Biographical Overview**

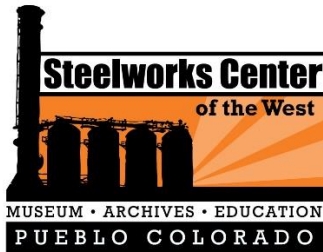
Please submit a short (150-250 words) narrative explaining to the BHS' Nomination Selection Committee why you are nominating this individual for 2020 CF&I Hall of Fame.

#### **Narrative Points to address**

- Years of service at CF&I.
- Department(s) worked in at CF&I.
- What are the candidate's contributions to the Pueblo community?  
In doing so, was the candidate merely doing their job or did they go beyond their paid duties?  
Is the candidate a Pueblo native?
- Is the candidate from another state, but spent the majority of his/her career in Pueblo?
- Has the candidate shed good light on Pueblo through his/her personal and professional career?
- Share a personal story or memory of the candidate while working at CF&I. How did their employment at CF&I enhance their life and the lives of those around them?
- What makes the candidate unique from his/her contemporaries?

Be as detailed as possible.

Remember that the members of the selection committee may not be familiar with the individual being presented for nomination.



## CF&I Hall of Fame Nomination Form

In 2018, the FACES 2019 planning committee determined to change the format of the organization's yearly fundraiser and honor the past workers of the Colorado Fuel & Iron Company (CF&I).

- Nominees must have been employees of CF&I prior to 1993, when the company ended.
- *are considered on the basis of contributions in the following areas: all faces of education; business and labor; arts and humanities; philanthropy; government; law; science and technology; and health and human services.*
- Persons selected for honoring at FACES of CF&I 2020 Fundraiser do not have to be current residents of Pueblo, but if selected, relatives must be able to attend and accept the award on their behalf.
- Posthumous nominations are accepted. If selected, a living relative must be able to attend the event in their honor.
- Selections are made without regard to gender, race, religion, or national origin.

Inductees are selected by a non-partisan selection committee composed of Board Members, Steelworks Members and other community members.

Selected honorees are honored at the FACES of CF&I 2020 Fundraiser on Saturday, February 8, 2020.

Portraits and biographies of the selected honorees are displayed in a commemorative program as well as in the evening's presentation.

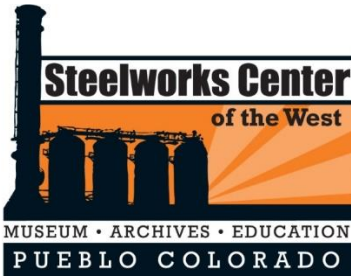
